

USED CATALYTIC CONVERTER RECYCLING FORM INSTRUCTIONS

1. Open the page www.emission-partner.de/en/recycling
2. Fill in the form with your **personal/company details**.
3. Please check one of **the three shipping options** under point 5 in the form:
 1. **Returns** by DHL
 2. **Collection**
 3. **Personal return**

Free return shipment by DHL for used catalytic converters weighing **up to 31.5 kg**:

1. Check „Return“ in the form
2. You can use the link in the form to open, fill in and print out the DHL returns form.

Collection of used catalytic converters with a weight **over 31.5 kg**:

1. Mark „Collection“ on the form and specify the desired collection date.
2. We will organize the collection for you and inform you of the collection date by e-mail.

4. Once you have completed the Altkat form, please print it out (CTRL + P) in landscape format and click on „Finish“.

Note: The form will not be sent to us until you click on „Finish“.

Free return shipment by DHL for used catalytic converters weighing **up to 31.5 kg**:

3. Pack used catalytic converters as a package for transportation.
4. Include the printed and completed used catalytic converter form in the package.
5. Stick the DHL return slip on the parcel.
6. Hand in the parcel at the DHL station.
7. Full payment. Shipping costs are covered by us.

Collection of used catalytic converters with a weight **over 31.5 kg**:

3. Attach old cats to pallet.
4. Add the used catalytic converter form to the pallet/used catalytic converter.
5. Freight forwarder collects the pallet.
6. The shipping costs of 45 € (up to 100 kg) or 85 € (from 100 kg) will be deducted from the payment.

5. The used catalytic converters arrive at our production facility and are inspected. You will then receive a credit note within the next 14 days. The amount depends on the precious metals still available.
